**£25**, including the first tariff heading, additional tariff headings thereafter are **£2.50** each.

### Required Documentation & Departure Information

In order to process an export declaration, we need the following documentation:

- ☒ CMR, shipping or consignment note.
- ☒ Commercial invoice/packing list specifying tariff codes, weight, value, quantity and origin of manufacture.
- ☒ U.K. export terminal and date and time of departure.
- ☒ UK registered & activated EORI number.
