You have 4 options:

A

As your appointed Customs Intermediary, we would complete either a 'Non-inventory linked' or an 'Inventory-linked' customs clearance on your behalf. This allows a seamless transition into the U.K.

Yes 2 Ship would settle any VAT or Duty via our client HMRC deferment account.

This is the easiest and quickest option as Yes 2 Ship handles the entry from start to finish!

C

The importer has the option to postpone the payment of the VAT element of their import clearance until the end of the current tax period (quarterly). This requires the importer to have a system of records in place to ensure an audit trail is kept and to also be enrolled onto the monthly VAT HMRC reporting system. This is **NOT** a suitable option for infrequent or one-off importers. If Duty is applicable, it is immediately payable.

B

As your appointed Customs Intermediary, we would complete either a 'Non-Inventory' or an 'Inventory' customs clearance on your behalf. This allows a seamless transition into the U.K. Taxes (if applicable) are paid via the **importers** (customers) registered HMRC deferment

D

For food, perishables and items that do not attract VAT or Duty, we as your appointed Customs Intermediary would do a 'Non-inventory linked' or 'Inventory linked' customs clearance (depending on the port of entry). Normally there is no VAT due, however Duty (if applicable) is immediately payable.

Customs Clearance Price Options

A

U.K. Import Customs Clearance: **£25** including the first tariff heading, thereafter, each tariff heading is **£2.50**. A **2.5%** agency fee of any VAT/Duty advanced on your behalf / minimum of £25 would apply.

B

U.K. Import Customs Clearance: **£25** including the first tariff heading, thereafter, each tariff heading is **£2.50**. Taxes, if applicable, are paid from the importers own HMRC registered deferment account.

C

U.K. Import Customs Clearance: **£35** including the first tariff heading, thereafter, each tariff heading is **£3.50**. Taxes, if applicable, are postponed against the importers registered PVA account.

D

U.K. Import Customs Clearance: **£35** including the first tariff heading, thereafter, each tariff heading is **£3.50**. Taxes, if applicable, are either paid by Yes 2 Ship (T&C's apply), placed against importers deferment account or postponed on PVA, if the importer is registered.
